Leadership team assembled for Public Safety Department

Reuben Young, secretary of the new N.C. Department of Public Safety, has completed assembling his senior leadership team.

The agency, which consolidates the departments of Crime Control and Public Safety (CCPS), Correction and Juvenile Justice and Delinquency Prevention (JJDP), becomes effective Jan. 1. Members of the new leadership team are:

Gerald A. "Rudy" Rudisill will be chief deputy secretary for the Division of Law Enforcement, overseeing the divisions of Alcohol Law Enforcement, Butner Public Safety, State Capitol Police and State Highway Patrol. Rudisill currently serves as the CCPS chief deputy secretary.



Officers' bravery wins national honor

A national association has honored two Pasquotank Correctional Institution officers for their courageous response during an assault on one of them last year.

The American Correctional Officers Association presented a Gold Medal of Honor to Correctional Officer **Cassie Fueston** and Sgt. **Brian Eason** on Oct. 14 during the group's annual meeting in New Orleans.

Officer Fueston's award was presented "for her bravery and persistence" when she was ambushed by an inmate armed with two handmade weapons.

The inmate stabbed Officer Fueston multiple times in the stomach and back and punched her in the face. Officer Fueston was able to deter the attack just long enough to exit the dorm. At that time, Sgt. Brian Eason entered the dorm to subdue the inmate.

Without pause or regard for her lacerations, puncture wounds, and painful swelling, Officer Fueston re-entered the dorm to assist Sgt.

"We recognize Officer Fueston ... for her active and unrelenting service during a safety-compromising situation on the job," the officers association stated.

Sgt. Eason's Gold Medal of Honor was for "his selfless assistance" to Officer Fueston. He responded when he heard Officer Fueston screaming while she was being violently assaulted.

While Officer Fueston was breaking away from the inmate and his assault, Sgt. Eason

Connie Morris is a correctional officer at Bertie Correctional Institution in Windsor. More importantly, she is a North Carolina hero.

On May 8, 2010, Morris was enjoying a leisure outing to Sheep's Landing on the Chowan River. At that same time, five year old Dillon Williams of Merry Hill was playing in the water with several other children. One of the children reported that Dillon was nowhere to be seen and, in



no time, a search for the child began. Dillon was soon spotted by one of the other children floating face down in the water.

Morris quickly retrieved Dillon from the water. His small body was limp and his skin color was blue, especially his lips. Dillon was not breathing. He had no pulse and he appeared lifeless. Morris, realizing that time was a crucial factor, began chest compression immediately. Nothing happened.

Frustration set in and Morris began to think that it was too late. Suddenly, however, water came out of Dillon's mouth and nose. Morris rolled Dillon over to his side to get the water out. Dillon began to cough and cry - very welcome sounds to hear in a potential drowning situation.

Due to Morris's quick actions, her knowledge of CPR and her determination not to guit, five year old Dillon Williams survived. Thanks to Officer Morris, he will be able to play and swim with his friends once again.

On Nov. 29, for her heroism, Officer Morris was presented the Governor's Award for Excellence in a ceremony in Raleigh.

Gov. Bev Perdue said, "Thank you, Connie Morris, for your quick response and for saving the life of one of North Carolina's youngest citizens."

Secretary Young announces office locations for new department

Reuben Young, secretary of the new Department of Public Safety, has announced locations for the agency's offices in Raleigh.

"Nowthat we have the major personnel decisions made, we are able to move on to the day-to-day concerns — and this is a big one for all of us who spend most

of our waking hours in a state government office," he said. "Especially as you've seen people walking through your buildings, floor plans in hand, I'm sure you've wondered who will move where.

The following office allocations have been decided:

The senior leadership team will occupy two floors of the Archdale Building. The Secretary's office will be on the 14th floor, along with those of his chief deputy secretaries, the general counsel's office and some administrative staff. Rhonda Raney and her external affairs team, which includes communications and legislative affairs, will move to the second floor.

Tim Harrell and the Internal Audit team will occupy offices on the ground Floor of Archdale. Also, the Highway Patrol headquarters will remain in the Archdale Building.

Core operations team members for Juvenile Justice will remain at their current location at Hammond Business Place. The Purchasing group under Director Drew Harbinson will be at that location as well.

The Finance and Budget groups under Controller Marvin Mervin and Budget Director Cassandra Watford will consolidate at 2020 Yonkers Road. DOC's fiscal employees, who make up a majority of those two areas, are already in office space there.

Engineers from Juvenile Justice will join their new engineering colleagues in expanded space at Yonkers

Director Al Ragland and his HR team will move into the Shore Building at 214 W. Jones St. Most of DOC's HR team is already located there.

Director Gwen Norville and the Staff Development group will be located at Gwen's

current location, 2211 Schieffelin Rd. in Apex.

The DOC's PREA employees, EEO employees and Nicole Sullivan and her Research and Planning group will have offices in Archdale. Their exact locations are to be determined.

Employees whose groups are not on the list above will most likely stay where they are. There may be some consolidation required on individual floors or in specific areas, but their move will be limited.

The transition staff is working with the Department of Administration to ensure there will be adequate parking to meet the needs for all downtown employees at the standard state employee rates.

"I hope this information helps set your minds at ease and clears up any uncertainty," Young said. "I understand how important your office space is, and I hope these changes will ensure we all have space that helps us to be as productive and happy as possible.

Central Prison has new warden

RALEIGH - Kenneth Lassiter, a 22-year veteran in the N.C. Division of Prisons, is the new warden of Central Prison, succeeding the retired Gerald Branker. Lassiter was previously superintendent of Charlotte Correctional Center.

Lassiter is in charge of a prison that houses 1,000 adult male inmates in close custody, and has a staff of 700 correctional officers and support personnel.



The prison houses the state's execution chamber, deathwatch area and men's death row. A new hospital and mental health facility serve inmates from across the state.

Central Prison is also a diagnostic center, the point of entry into the prison system for male felons, age 22 years or older, with sentences longer than 20 years.

Lassiter began his career as a correctional officer at Odom Correctional Institution in 1989, rising through the ranks at the Odom, Lanesboro and Pasquotank facilities. He was assistant superintendent at Pasquotank Correctional before his promotion to superintendent in Charlotte.

The new Central Prison warden graduated from Halifax County's Northwest High School, attended Big Ben and South Piedmont community colleges, and served in the U.S. Army 1985-89. He has completed the National Institute of Corrections' New Wardens Training and the Department of Correction's executive leadership development program.

Lassiter and his wife, Kimberly, have three daughters.

Public manager program graduates 3 from DOC

Three Department of Correction employees graduated from the state's Certified Public Manager (CPM) Program on Oct. 3.

The program provides in-depth, comprehensive, competency-based leadership development to middle managers in state government agencies. A graduate earns the Certified Public Manager™ designation, which is

recognized by a National CPM Consortium of over 40 states and public sector entities.

Approximately 12 in-class days (80 hours) are required of participants during the 16-month CPM Program. Additionally, 120 hours are required outside the classroom sessions to complete online modules, and pre/post class assignments.

State Health Plan: Coaching pilot project at DOC produces positive results

A pilot project testing the benefits of health service interventions with Deparment of Correction employees has produced positive results, according to the N.C. State Health Plan for Teachers and State Employees.

Conducted over a one-year period, the project conducted onsite biometric screenings and one-on-one health coaching with volunteer employees at Central Prison, N.C. Correctional Institution for Women and the Yonkers Road administrative offices.

The project sought intervention data in a shift-based, custodial work environment. Biometric screenings were conducted, in May 2010 and 2011, and health coaching was conducted between screenings.



The one-on-one coaching sessions provided guidance on how to establish and meet personal health goals, which led to sustained behavior change for many of the participants. Participants reported this component of the program to be the most helpful in achieving stated health goals.

Of the 242 participants who completed the final survey, 96% reported improved health status as a result of the program, and 93% indicated they will continue to work toward



improving their health. The project

also facilitated coordination of care: 78% of those who saw a doctor shared their screening results and nearly 20% had a change in their medications.

The project produced positive changes in disease status and risk among the 145 employees who participated in both the baseline and the follow-up screenings. The most significant improvements were seen in blood pressure,

body mass index (BMI) and waist circumference.

- > The number of participants with measures of hypertension at baseline decreased by 34%.
- > BMI reduced from an average of 34.5 to 33.8.
- > Waist circumference reduced from an average of 42.2 inches to 41.3 inches.

Risk for type 2 diabetes and stroke also decreased. Participants stratified into the highest risk pool for diabetes reduced by 5%. Predicted new cases of strokes over the next five years decreased by 12%.

Strong leadership support throughout the project led to high participation and satisfaction rates among employees; 22% cited "encouragement from leadership" as a reason to participate.

Cyber security makes sense in any shopping season

As holiday shopping kicks into gear, it's time for a security reminder. Here are six tips for safe online shopping

- Shop with a credit card, not a
 debit card. Credit cards have
 much better built-in consumer
 safeguards than do debit cards. If
 your debit card number gets stolen, it'll be more complicated to
 sort things out, especially if fraud
 causes overdrafts and bounced
 checks.
- 2. Keep track of your receipts. Some experts advise online shoppers to print out all receipts. That's fine, but you may also choose to simply take a screen shot of your order details, or save the page itself as an HTML file.
- 3. Avoid bargain-basement shopping online. There's nothing wrong with wanting the best price, but every holiday season, an army of phony Internet stores pop up with the sole purpose of ripping off consumers who only look at the price. Many experts advise going with larger, trusted stores.

- 4. Double-check shipping policies. Make sure you understand the shipping and return policies before you click that "buy" button. Look for stores that offer a shipping date guarantee, and make sure the items you want are actually in stock.
- 5. Read the fine print. Just as you may find your browser sporting a new toolbar if you rush through an update of your media player or PDF reader, being in a hurry when you make a web purchase can cause you to inadvertently sign up for unwanted offers.
- 6. Shopping online at work could be hazardous to your career. The Monday after Thanksgiving is often referred to as "Cyber Monday" because many shoppers use the day to buy stuff online that they poked at and played with in stores over the previous weekend. But you might want to think twice about online shopping while at work. Employers know it's a popular shopping time, and track bandwidth use accordingly.

Community Corrections District 10 is made up of Wake County. It has one district manager, two assistant district managers, two office assistant IVs, and one administrative assistant.

The district also has 15 units, each with chief probation/parole officer. The units altogether have eight office assistant III's, 12 intensive surveillance officers, 100 probation officers and one probation field services specialist.

District 10 also has two processing assistant IV's, three judicial services specialists and 16 judicial service coordinators.

In all, the district 63 staff members.

The offender population in Wake County is approximately 6,200. Wake County has 12 criminal courtrooms, generating new cases that operate simultaneously daily.

In addition to the typical program and monitoring resources in the agency, District 10 operates specialized drug treatment courts (DTC), with four DTC officers assigned to supervise the DTC cases. District 10 also has four sex offender officers assigned to supervise all registered sex offenders under supervision in the district.

The district has a Day Reporting Center that offers GED services, substance abuse treatment, cognitive behavioral intervention and electrical wiring classes.

District 10 has officers who work closely with the county high schools to ensure a close working relationship with school administrators and personnel.

The Domestic Violence progam in District 10 is very strong. It works closely with a specialized court to ensure compliance with court-ordered conditions and to address the needs of these offenders.

The district's Community Threat Group officers work closely with local law enforcement to ensure compliance with court-ordered gang conditions.

District 10 has a large Judicial Services Unit charged with processing thousands of cases each year. It serves approximately 10 courtrooms each day of the week and

processes approximately 200 supervised and unsupervised cases per week. As the cornerstone of District 10, the Judicial Services employees are passionate about the work they perform to ensure cases are processed accurately, efficiently and timely.

Wake County has a mostly urban population, with many outer lying rural areas. Our probation officers work closely with 16 different law enforcement agencies during the course of their work days, receiving and providing assistance along with information in an effort to carry out the mis-

sion of DCC.

"Our officers are dedicated to changing offender behavior and making a difference in our community," said District Manager **Maggie Brewer**. "They achieve this goal by utilizing the tools provided by our agency along with community resources to provide our offenders with the best opportunity to succeed while under supervision.

"Each day, I am amazed at the high volume of work each of our employees accomplishes. For me, it is an honor and a privilege to work with our District 10 employees."
